- 1. The Mou witness and agreed by and between the parties is as follows.
 - a) The hospital has agreed to provide ambulance facility In case of emergency.
 - b) Any revision in the charges will immediately be brought to the notice of the authorities of the society.
 - c) The Society and the hospital will have no objection in using their name and other relevant information in advertisement, websites, promotion, literature etc.
 - d) All services provided by the hospital shall be according to the parameters and clinical protocols.
 - e) The society will not interfere in the treatment and medical services provided by the hospital to the students and employees of the college / institutes, unless it is required.
- 2. The hospital not discloses or share or my information about the students, employees or the business activities of the society with outsider or other agencies involved in similar.
- 3. The Mou shall come into force with effect from 08 August 2023-24 less than one month / three months' notice is writing.
- 4. All the disputes or differences arising out of it and connected with the mou shall be referred to the arbitrator in accordance with the Indian

- arbitration act .the courts in Nasik shall only have jurisdiction to exclusion of all other courts.
- 5. Under this Mou, the first party / hospital shall admit duty authorized students and employees of the college /institutes of the society without any advance deposit to be paid at time of admission as an indoor patient (IP) and provide 10% discount to students & medical checkup charges.
- 6. The society will refer the patient with the appropriate documents as mentioned in the annexure -1 attached herewith for getting treatment as an indoor patient, emergency cases, etc. in the hospital of first party.
- 7. The hospital shall notify and update the society, by submitting list of mediclaim insurance complaints with which the hospital has tie up for cashless medical /Hospitalization facility. The society shall inform/publicize such details to the student's, parents, employees and encourage them to get the policy from such insurance companies.
- 8. In case of exigency or holidays or Sundays or night hours the hospital will admit the patient upon telephonic instruction from any of the authorized person/ officials mentioned in the Annexure 1 of the society so to proceed for the handing of exigency fourth without delay. The appropriate document in such cases would be deposited with the hospital by concerned from the society within 48 hours of admission.
- 9. That the terms & conditions of this Mou will be reviewed after every 12 months or earlier in case of special circumstances.
- 10.If some mishap happen with the students & staff in the college premises only then college will take responsibility of payment.
- 11.TERMINATION;
- a) Either party may terminate the agreement by issuing one month's prior notice in writing to the other party.
- b) In case of termination by the hospital, the hospital shall remain responsible for all assignments being attended to by hospital at the time of termination of the agreement.
