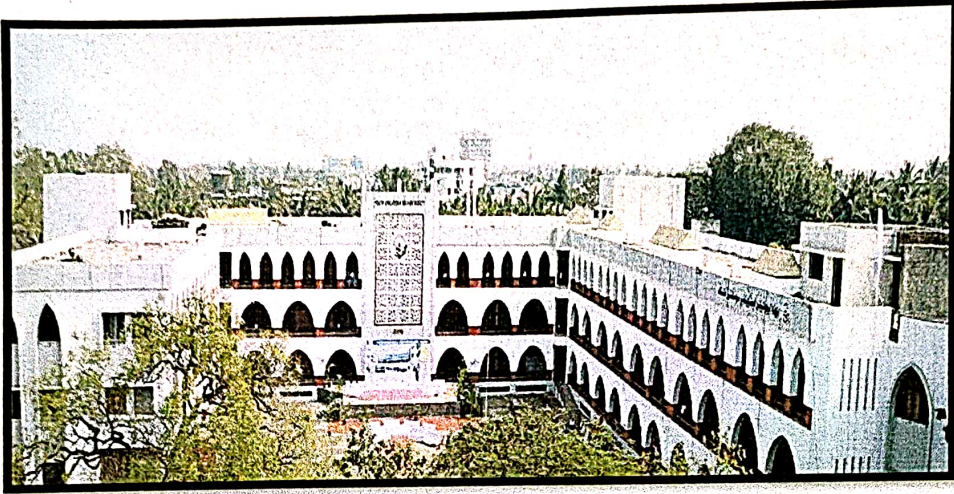

Report on "GST Guidance Program"

The GST Guidance Program were arranged by the Department of Commerce at National Senior College, Nashik on Monday 11th March 2024, 08:00am followed by the Guest Lecture of CA Pritam Bagmar & CS Shital Bagmar. The program were started by the felicitation of guest and Respected Principal Dr. S. B. Nahire. The Respected Principal Dr. S. B. Nahire guided students about the benefits of the Goods and Service Tax. Head of the Commerce Department Asst. Prof. Ranjana Mahajan given the brief introduction about the guest. The guest CA Pritam Bagmar spoke about the various important concepts related to Goods and Service Tax. They also given the practical examples about filing of GST. One demonstration were also performed by referring to the GST number of one random receipt, from which they showed all the details of the particular firm. They also spoke about the Importance of the Goods and Service Tax (GST).

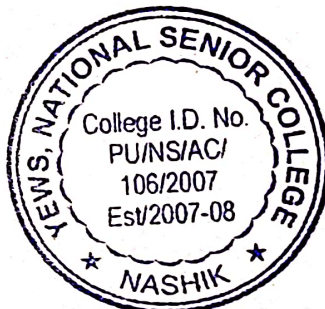
CS Shital Bagmar taken and interactive session about the GST where she explained the history of the taxation system, the types of taxes that exists earlier. They also given the brief introduction about how the GST was implemented. She also explained that GST is an indirect tax which has replaced many indirect taxes in India such as the excise duty, VAT, services tax, etc. The Goods and Service Tax Act was passed in the Parliament on 29th March 2017 and came into effect on 1st July 2017. He also explained that Goods and Service Tax (GST) is levied on the supply of goods and services. Goods and Services Tax Law in India is a comprehensive, multi-stage, destination-based tax that is levied on every value addition. GST is a single domestic indirect tax law for the entire country.

The anchoring of the program were done by the Asst. Prof. Sadiya Ansari. Program Arrangements were done by the Asst. Prof. Rushikesh Zute. Asst. Prof. Sadiya Ansari given the brief introduction about the Programme. The Respected Head of the Commerce Department Asst. Prof. Ranjana Mahajan also guided the students about old taxation system and the benefits of one nation one tax policy also the Importance of Goods and Service Tax.
